### Orientation Programme

Day first session was presided by Mr. Kang Balwinder, who lead the Personal Excellence program and taught students, with unique learning ideas with self-reflection and fun. The second day session was designed for the law students where Dr, Rajesh Gupta enlighten the students about the Importance of legal profession. He also enlightened the students with the challenges in a career path of students, and how to face it and convert such challenges into opportunity. ## Legal Awareness Camp “Green India Clean India”

This awareness Camp was organized by the Legal Aid Cell of Innovative Institute of Law along with the volunteers of the Legal Aid Committee, where Volunteers visited a village “Navada” and organized a camp in Government School and made students aware about the importance of cleanliness, and how it will help them to live a healthy life. Volunteers also conducted a survey in the same village to know the basic living standards and common problems faced by people in day to day life.



### Police Station Visit

As the part of academic curriculum every student who looks to make their career in law, have to understand the basic function of different legal fraternity and one of them is the role of the police. So to familiarize them with the working of Police Station and how Police Personnels deal with the criminals and the different approach towards dealing different criminals, a visit of Police Station was organised. The students also came to know about the lock-up and Police diary and the use of Police diary. The SHO enlightened the students with the basic challenges they faced and how the harmonious relationship between police and judiciary is maintained.

### Legal Aid Program

In collaboration with District Legal Service Authority this Program was organized in Village Tugalpur, where downtrodden people were helped through this programme. Our students with the help of different Nukkad Natak make them understand about different schemes of Government and how they can be benefited with such schemes. Our volunteers also conducted individual counseling in that program, who approached our volunteers in regard to avail such government benefits.



### INTRA-COLLEGE MOOT COURT COMPETITION

The Moot Court Committee of Innovative Institute of Law, organized its Intra- College Moot Court Competition. Total 12 teams participated in the Competition. They were judged by the distinguished panels of judges, who judged each teams on various rounds. The Memorials of each team were separately evaluated. The winner and runner - up team were felicitated with cash prizes and memento. Best Speakers, Best Researcher and Best Memorial Award were also given to students. The MCC aims to organize this event to enhance the skills of students and it is also one of the requirements to send our students to represent our Law School at other National Moot Court Competitions based on the rank they secured in the Intra-college Moot Court Competition.

## INNOVATIVE 1<sup>st</sup> NATIONAL MOOT COURT COMPETITION



The National Moot Court Competition was organized for the first time by the Innovative Institute of Law. The competition took place in a three-day event from April 29 to May 1. For this competition, a total of 27 teams from various universities all over India registered their names, out of which a total of 21 teams were selected.

On 29th April Innovative 1st National Moot court was inaugurated by our Chief Guest of inaugural function, Justice Mridula Mishra, former Judge of Patna High Court and Present Vice Chancellor of CNLU, Patna. She said that the dedication and curiosity of the students towards the Moot Court will definitely prove to be very useful. When we are in the court, it is very easy to understand who has come before the court with full preparation. It does not take long to understand that these are the same students who must have taken Moot Court seriously during their studies and also participated in Moot Court competitions.

Total 21 teams participated in the preliminary round, and the best performing 8 teams were selected for the quarter final round. A total of 4 court rooms were prepared for the quarter final round. Each team performed one to one in the quarter finals and the best 4 teams were selected for the semi-finals. The semi final and final round was held on 1st May. The final round was judged by Sh. Harish Chandra Mishra (Lokayukta of Delhi & former acting Chief Justice of Jharkhand High Court) and Judge Anjana Mishra (Armed force tribunal, Delhi and Former Judge, Patna High Court). The winner of the competition was Bharatiya Vidyapeeth, Paschim Vihar, Delhi who were honored with a certificate, trophy and a cash amount of Rs. 21,000/- and the runner up team, Vivekananda Global studies, with a certificate, award and, a cash amount of Rs. 11,000/- Cash Prize was also given to best Mooters, Researcher and Memorial Rs. 5000/- each and memento to all the participants.

## Lok Adalat Visit

The National Lok Adalat was conducted by The District Legal Service Authority at Surajpur, District Court in Greater Noida, Uttar Pradesh. On 12,13,14th March of 2022, 20 students from Innovative Institute of Law, visited and participated in Lok Adalat proceedings to gain knowledge about the settlement of the disputes. Students also observed the proceedings related with Motor Vehicle Accident claims and some family matters etc. Students also interacted with In charge of Lok Adalat Mr. Jaihind Singh who explained that the following cases can be settled in Lok Adalat, like Partition case, MVC, Financial Institution debt cases, etc. The main aim for the visit is that the students should be aware about the powers and functions of Lok Adalat with special reference to observe the mediation process and learn its tactics.
