## FAREWELL CEREMONY – 20TH JUNE 2025

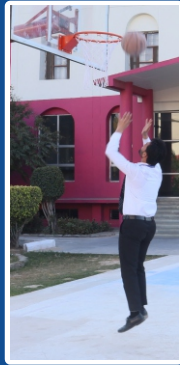
