As part of the clinical activity, the students of BALLB visited the Lok Adalat held at District Court, Surajpur, Greater Noida on 8th of April 2017. The Lok-Adalats are formal bodies set up under the state, but following the Alternative Dispute Resolution method to settle petty disputes that do not require any elaborate enquiry or evidentiary process.

The students witnessed the disposition of cases at the Lok-Adalat to get a first-hand account of legal proceedings.



#### Parliament Visit (13th April, 2017)

Innovative Institute of Law, orgainsed a visit to the Parliament of India, the federal legislative body of the Republic of India, on April 13, 2017 to make the law students understand the importance of the Parliament and its functions. The students visited the Rajya Sabha, the Lok Sabha and the Central Hall and also got the opportunity to interact with the officials of the Parliament.
